**SUBJECT:** Inter-Government Asset Transfer (San Juan College)

The Fire Department is requesting to transfer used fire hose, structural, ARFF and Wildland firefighting protective clothing to the San Juan College Fire Science program. The Fire Department has its own equipment and repair personnel for repairing fire hose and the hose listed for transfer is either irreparable or past its service life. The Fire Department also has its own certified repair personnel for inspection of personal protective clothing. All of the listed protective clothing is irreparable or past its service life. The San Juan College Fire Science program can use this equipment for drills in non-hazardous environments. These drills are very tough on equipment and one of the main causes of damage to it. This equipment will be used in lieu of newer equipment that the college already owns. The Fire Department no longer runs its own training academy and hires lateral fire fighters from the San Juan College program or anyone who meets the lateral firefighter qualifications. Attached is a list of all of the equipment and its respective information.
