All races start and finish at Lions Wilderness Park Amphitheater with the Cat-3 doing a 15-mile loop, and all other categories doing the 30-mile Road Apple Loop. Climbing on the course is minimal, making it fast and fun! When you do the whoop sections you will think you are in the air more than on the ground!

The Road Apple Rally offers classes for everyone. Athena and Clydesdale will participate in either Cat-2 or Cat-3, with no age categories.

Registration for the Road Apple Rally is \$45.00 by Wednesday, October 3, 2018.

Late Registration will be on Thursday, October 4, 2018 until 5:00 p.m. in-person only at the Farmington Recreation Center, 1101 Fairgrounds Rd., Farmington, NM. A \$15.00 late fee will be added.

Mail in registration must be received by Wednesday, October 3, 2018. Mail entries to Road Apple Rally, 901 Fairgrounds Rd., Farmington, NM 87401.

No faxed or scanned entries will be accepted.

Registration includes a race t-shirt, one Friday night dinner meal, and one Saturday lunch meal for the rider. Meals served at Lions Wilderness Pavilion. Additional meals may be purchased onsite for family and friends.

Packet pick-up will be at Lions Wilderness Pavilion on Friday, October 5, 2018 from 4:00 p.m. to 7:00 p.m., and on Saturday morning, October 6, 2018 from 7:00 a.m. to 8:00 a.m..

Again this year on Friday - Free Dirt Crit sprint race (available to registered racers) starting at 5:30 p.m. Onsite sign-up must be completed by 5:15 p.m.

## ACTIVITY WAIVER

Please read carefully and answer below

### ROAD APPLE RALLY

In consideration of the City of Farmington's permitting the participation of myself or family member in a bicycling or mountain biking event, I hereby for myself and my family member, personal representative and heirs, release and discharge the City of Farmington, any and all sponsoring organizations, their agents, successors and assigns, from all actions and claims for damages, cost, and expenses arising from an injury which may be suffered by myself or my family member arising out of participation in this program.

I understand and acknowledge that bicycling, bike touring, and mountain biking (referred to herein as activity) bears known risks and unanticipated risks which could result in injury, death, illness, disease, emotional distress, or damage to myself, to property, or to third parties. The following describes some, but not all, of these risks:

1) I realize that natural hazards do exist; that falls, collisions, and overturns may occur; that vehicles, curbs, uneven or unstable road & trail surfaces, trees, objects on the ground or in the roadway, or trail equipment failure, operator error, at the speed at which I travel can create hazards; that certain foreseen and unforeseen events can contribute to the unpredictability of the activity; that personal property may be damaged or lost; that I may suffer accidents or illnesses in remote places where there are no available medical facilities; that wearing a helmet is a basic safety precaution; and that I should ask about other potential hazards and recommended precautions and procedures.

**EXPRESS ASSUMPTION OF RISK AND RESPONSIBILITY:** In recognition of the inherent risks of the activity which I and any minor children for which I am responsible will engage in I confirm that I am (we are) physically and mentally capable of participating in the activity and/or using the equipment. I/We participate willingly and voluntarily and I assume full responsibility for personal injury, accidents or illness, including death.

I expressly, knowingly, and intelligently assume the following: all risks of travel, whether by car, bus, van, aircraft, boat, or any other means; all risks of riot, civil disobedience, hijacking; all risks associated with the preparation and eating of food, water, and beverages.

I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of the risks.

I hereby voluntarily release, forever discharge, and agree to hold harmless and indemnify The City from any and all liability, claims, demands, actions, or rights of action, which are related to, arise out of, or are in any way connected with my participation in this activity, including those allegedly attributable to the negligent acts of omissions of The City.

BY SIGNING OR AGREEING TO THIS DOCUMENT ELECTRONICALLY, I ACKNOWLEDGE THAT IF ANY ONE IS HURT OR PROPERTY IS DAMAGED DURING MY PARTICIPATION IN THIS ACTIVITY, I WILL HAVE NO RIGHT TO MAKE A CLAIM OR FILE A LAWSUIT AGAINST THE CITY, IT'S AGENTS, OWNERS, OFFICERS, EMPLOYEES, OR ANY OTHER PERSON OR ENTITY ACTING IN ANY CAPACITY ON ITS BEHALF EVEN IF THEY OR ANY OF THEM NEGLIGENTLY CAUSED SUCH INJURY OR DAMAGE.

Should The City, or anyone acting on its behalf, be required to incur attorneys' fees and costs to enforce this agreement, I agree to indemnify and reimburse them for such fees and costs.

I certify that I have health, accident, and liability insurance to cover any bodily injury or property damage I may cause or suffer while participating in this event, or else I agree to bear the costs of such injury or damage myself. I hereby authorize the City of Farmington to administer first aid or any medical treatment deemed necessary, arrange for emergency medical equipment or transportation in the event of an injury to myself or my family member while participating in the activity.
