

## RESOLUTION NO. 2020-1773

A RESOLUTION APPROVING THE SIDEWALK CONSTRUCTION FOR 20TH STREET PHASE III, NORTH DUSTIN AVENUE TO NORTH SULLIVAN AVENUE AND ACCEPTING FUNDS FROM THE NEW MEXICO DEPARTMENT OF TRANSPORTATION'S TRANSPORTATION ALTERNATIVE FLEXIBLE (TAPF) FUNDS, CN: F100132, FOR SUCH PROJECT

WHEREAS, New Mexico Department of Transportation (NMDOT) solicited proposed projects for funding under the New Mexico Department of Transportation's Transportation ALT Flexible TAPF program for Federal Fiscal Year 2021; and

WHEREAS, the City of Farmington submitted an application for Federal Fiscal Years 2018/2021 New Mexico Transportation Alternative Flexible (TAPF) Funds as set forth by the Federal legislation; and

WHEREAS, the 20th Street Project, Phase III, N Sullivan Ave to N Dustin Ave, named in the TAPF application was accepted as an eligible project under the New Mexico TAPF; and

WHEREAS, this project will allow the City to upgrade the ADA ramps to comply with PROWAG, install pedestrian push buttons and utilities, construct 5' separated sidewalk with the installation of landscaped buffer zones where right-of-way permits providing for better multimodal use along this busy commercial corridor.

NOW THEREFORE, BE IT RESOLVED by the Governing Body of the City of Farmington:


SECTION 1: That the City Council of the City of Farmington does hereby approve construction for the "20th Street Phase III" Sidewalk Project located on 20th Street between North Dustin Avenue and North Sullivan Avenue in the City of Farmington.

SECTION 2: That the City Council of the City of Farmington does further approve the total estimated cost of the 20th Street Phase III, Sidewalk Project, between North Dustin Avenue and North Sullivan Avenue, budgeting of the sum of Eight Hundred Thirty Two Thousand Nine Hundred Thirty Dollars (\$832,930) in Federal Fiscal Year 2021 for such project upon the understanding that Seven Hundred Eleven Thousand Six Hundred Fifty Five Dollars (\$711,655) shall be paid for by funds from the NMDOT's Transportation Alt Flexible (TAPF) Funds (85.44%) and One Hundred Twenty One Thousand Two Hundred Seventy Five Dollars (\$121,275) will be paid for by the City of Farmington.

SECTION 3: That the City Council of the City of Farmington does further represent that funds, equipment, labor and materials representing the total cost of the proposed project was budgeted in Fiscal Year 2021 and will be available when the agreement of such project becomes effective.


SECTION 4: That the City Council of the City of Farmington does further authorize the Mayor of the City of Farmington to enter into appropriate contracts with the New Mexico Department of Transportation for construction of any, or all, of the project described in this resolution under the Cooperative Project Agreement - Construction (COOP) of the State of New Mexico.
