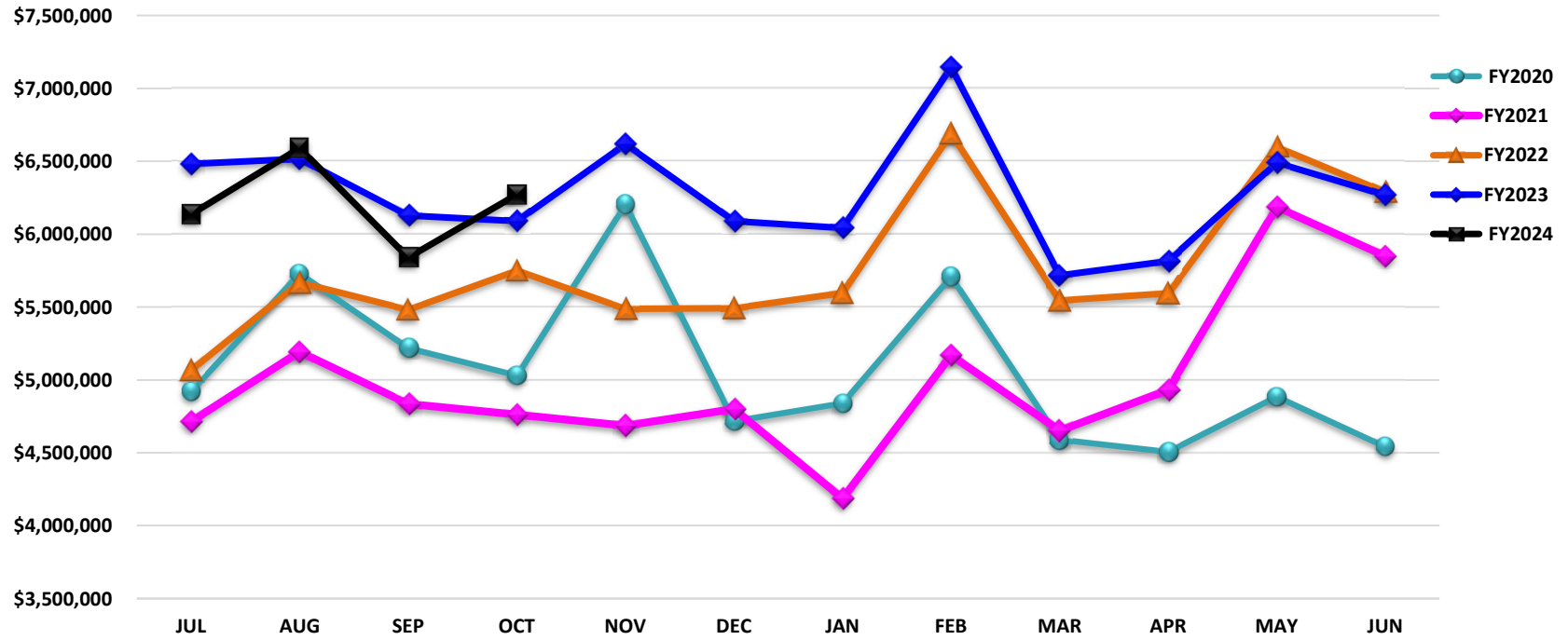
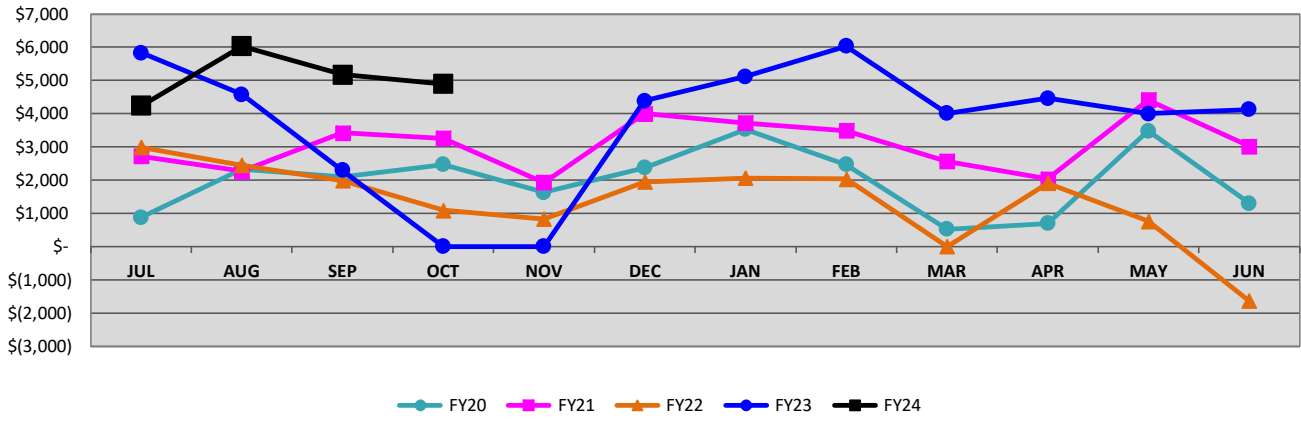


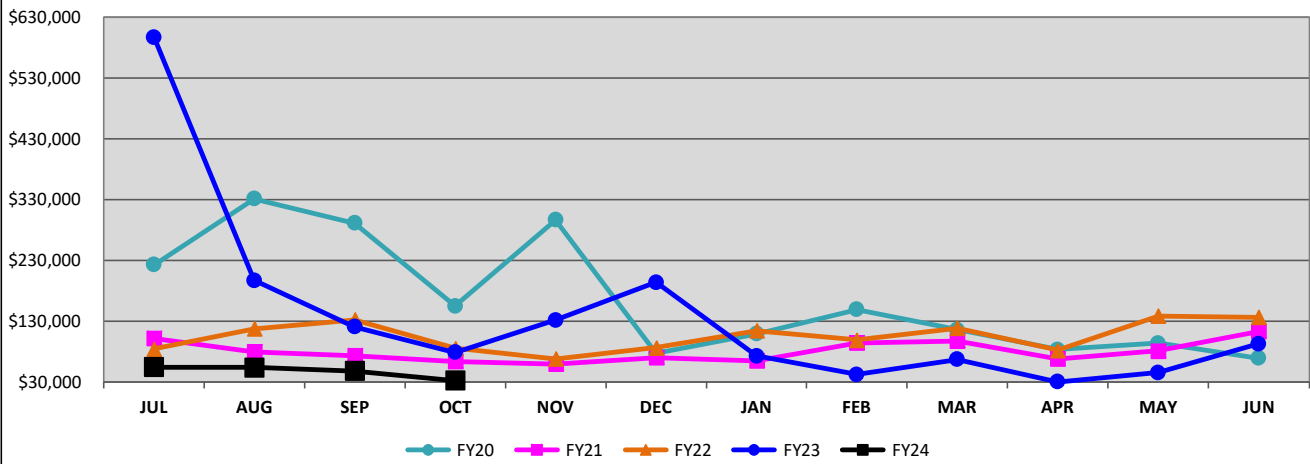
City of Farmington Gross Receipts Tax Revenue By Month FY2020 - FY2024 YTD



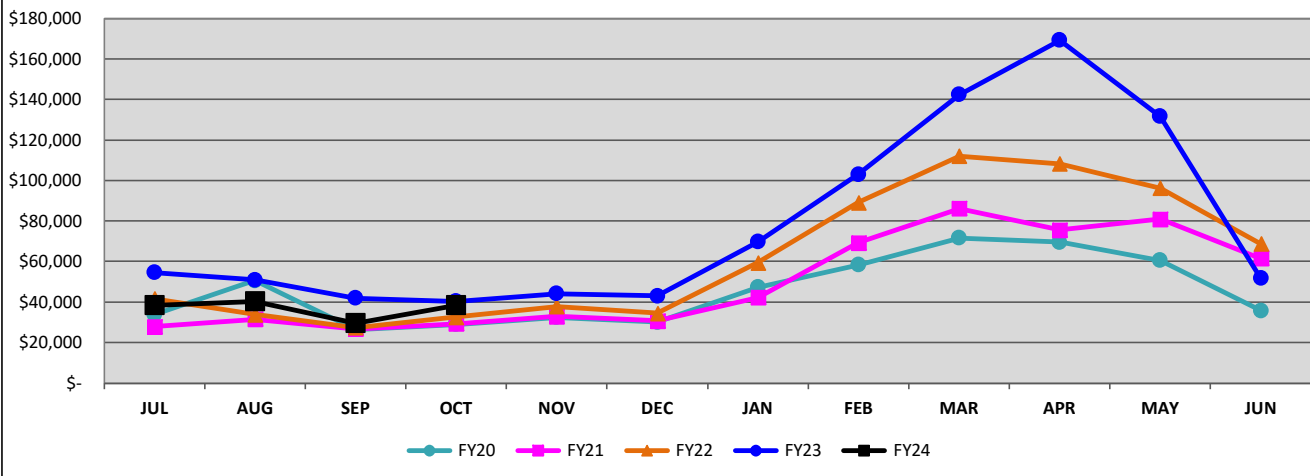
