A RESOLUTION SETTING AND ESTABLISHING A REGULAR MEETING DAY, TIME AND PLACE FOR THE COMMUNITY RELATIONS COMMISSION PURSUANT TO CITY COUNCIL RESOLUTION NO. 96-844 AS RATIFIED AND AMENDED
