JOB DUTIES

ESSENTIAL DUTIES:

Using excellent customer service skills, establishes and maintains effective working relationships with other employees, officials, and all members of the general public.

Works under the supervision of the Costumer.

Assists Costumer with duties as assigned to ensure performers have complete costumes.

May act as Costumer during Costumer's absence.

Operates a motor vehicle to assist in carrying out the business of the department and the City. May drive city vehicles in performing errands for the amphitheater facility.

Keeps regular inventory of all costumes and accessories owned by the production company.

Assists with the fittings for cast members and selection of appropriate costumes and jewelry.

Assist in the design, construction and/or purchase of any costumes needed for the season, as deemed necessary by the costumer and director.

Performs repairs to costumes as needed during the production run.

Assists in the development and maintenance of costumes during the production run.

Assists in maintaining continuity of the show by making sure actors wear correct costumes at all performances.

Assists actors in costume changes during quick changes.

Assists with makeup.

Assists with inventory and costume storage at end of season.

At all times, encourages a positive attitude among actors and production crew staff.

JOB #21 – ASSISTANT COSTUMER

Attendance at work is an essential function of this position.

NON-ESSENTIAL DUTIES:

The duties listed above are intended only as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related or logical assignment to the position.

QUALIFICATIONS

This position is subject to the City of Farmington's Drug and Alcohol Free Workplace Program.

This includes, pre-employment testing, post-accident testing, reasonable suspicion testing, return to duty testing, and follow-up testing.

Must be 16 years of age or older at time of employment.

Extensive background checks required.

Valid New Mexico driver's license with acceptable driving record for the past three years.

Ability to count money and make change.

Training in Basic First Aid, CPR, and proper response to bio-hazardous spills as mandated by OSHA regulations, preferred but not required.

Ability to work courteously with the public and with co-workers.

Ability to learn to use basic cleaning materials.

Willingness and ability to understand and implement provided training.

TOOLS AND EQUIPMENT USED:

Janitorial equipment including vacuums, mops, brooms, dusting equipment, cash register, credit card machine, kitchen equipment and tools, motor vehicle, golf cart and 2-way radio.

PHYSICAL DEMANDS:

While performing the duties of this job, the employee is regularly required to reach with hands and arms. The employee frequently is required to stand; walk; and use hands to finger, handle, feel or operate objects, tools, or controls and talk or hear. The employee is occasionally required to sit; climb or balance; stoop, kneel, crouch, or crawl.

The employee may frequently lift and/or move up to 50 pounds. Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception, and the ability to adjust focus.

WORK ENVIRONMENT:

While performing the duties of this job, the employee occasionally works near moving mechanical parts and frequently works in outside weather conditions. The employee is occasionally exposed to wet and/or humid conditions and lightning.

Works outside in all types of weather conditions. Extensive walking, and occasional running, throughout the rugged terrain of the six acre complex will be required.

The noise level in the work environment is moderate to loud.
