**DEPARTMENT HEAD REPORTS**

1. Consideration of proposed street name assignments for Mesa Mobile Home Park (Beth Escobar)

Action Requested of Council:

Approve the proposed street name assignments.

Background/Rationale:

Farmington Electric Utility Service is working with the owner of Mesa Mobile Home Park to convert electric service for this residential mobile home park from a single master meter to individual meters for each residence. The new individual meters will need to receive separate addresses in order to be input into the billing system. Currently, residences in this park are identified by a space number which is not consistent or logical.

After meeting with Fire and Police personnel, staff designed a new addressing system for the entire park. This includes adopting new street names and an address numbering system that is consistent with the City's addressing policy. There have been emergency response issues with the current addressing system in Mesa Mobile Home Park which should be addressed by converting the park into this new addressing system.

Staff is coordinating this project with FEUS to align with installation of the individual meters and has met with the owner of Mesa Mobile Home Park who supports the address conversion. Staff will work with residents and the post office to facilitate the change in addressing.

Staff Recommendation:

Approve the following street name assignments for Mesa Mobile Home Park:

- Robin Avenue
- Oriole Avenue
- Finch Avenue
- Meadow Lark Avenue

These are continuations of existing streets to the south in the Westside Estates Subdivision which is located to the south of Mesa Mobile Home Park.

In addition, nine new street names are proposed:

- Wren Avenue
- Crane Avenue
- Crow Street
- Egret Street
- Loon Street
- Magpie Street
- Ostrich Street
- Parrot Street
- Pelican Street
- Toucan Street
- Heron Street

Instructions Upon Approval:

Staff will proceed with the assignment of new street names for Mesa Mobile Home Park.

Budgetary Impact:

The property owner will bear the cost of the new street signs and all other associated costs are included in the Planning Division's current budget.

RESOLUTION NO. 2019-1729

A RESOLUTION PROCLAIMING SEPTEMBER 17 THROUGH 23, 2019 AS  
CONSTITUTION WEEK

WHEREAS, The Constitution of the United States of America, the guardian of our liberties, embodies the principles of limited government in a Republic dedicated to rule by law; and

WHEREAS, September 17, 2019, marks the two hundred and thirty-second anniversary of the framing of the Constitution of the United States of America by the Constitutional Convention; and

WHEREAS, It is fitting and proper to accord official recognition to this magnificent document and its memorable anniversary, and to the patriotic celebrations which will commemorate it; and

WHEREAS, Public Law 915 guarantees the issuing of a proclamation each year by the President of the United States of America designating September 17 through 23 as Constitution Week.

NOW, THEREFORE, BE IT RESOLVED by the virtue of the authority vested in the city council of the City of Farmington, do hereby proclaim the week of September 17 through 23 as Constitution Week and ask our citizens to reaffirm the ideals the Framers of the Constitution had in 1787 by vigilantly protecting the freedoms guaranteed to us through this guardian of our liberties.
